德国莱茵TÜV是伊拉克中央标准质量控制局(COSQC)的指定认可机构,可对出口至伊拉克的货物按照进口前检验、测试和认证(ICIGI)计划的要求进行评定验证。该计划旨在确保进入伊拉克市场的产品均符合当地标准及其它相关标准,目的是保障伊拉克国内消费者的健康及人身安全,并降低货物抵达伊拉克后遭到拒收的风险。

The Central Organization for Standardization and Quality Control (COSQC) has appointed TÜV Rheinland as a certification body for its Pre-Import Inspection, Testing and Certification of Goods into the Republic of Iraq (ICIGI) programme. The objective of this programme is to ensure that goods imported into Iraq conform to the Iraqi standards or other standards approved by COSQC, safeguard the health and safety of Iraqi consumers and minimise the risk that the goods will be rejected when they reach Iraq.
