

# 沙特阿拉伯出口认证 Your Market Access to Saudi Arabian

根据沙特阿拉伯国家标准局(SASO)和沙特阿拉伯商业部(MoCI)的规定,大部分出口到沙特阿拉伯的产品需通过强制性产品认证。受检测产品在到达沙特阿拉伯之前必须取得合格发证机构所核发的符合性证明(CoC),沙特阿拉伯的官方机构会在到货港口对产品进行抽样检查,以确定产品和CoC的一致性。CoC需由国际实验室认可组织(ILAC)成员,或者与SASO互相承认的机构(MRA)颁发。德国莱茵TÜV的众多实验室都已获得ILAC成员的正式认可,可以为需要出口到沙特的产品颁发CoC。

According to the regulations of the Saudi Arabian Standards Organisation (SASO) and Ministry of Commerce and Industry (MoCI), most products entering the Kingdom of Saudi Arabia (KSA) are subject to compulsory certification Any product subject to testing must obtain a Certificate of Conformity (CoC) issued by a qualified organisation before it arrives in Saudi Arabia. Representatives of the relevant official KSA organisation will sample incoming goods at the port of arrival to ensure that they are consistent with the CoC.

CoC证书适用于所有进口至沙特阿拉伯的货物,以下产品除外 The scope and field of application of this program is issuing certificates of conformity for all commodities and products intended to be exported to Saudi Arabia excluding the following items:

- 医疗器械 Medical devices and equipment
- 原油 Crude oil
