(hereafter referred to as "TRHK") have concluded the following Agreement:

1. The Client applies for the right to participate in the TRHK certification, verification and/or validation system.
2. TRHK and the Client recognize the attached

General Terms and Conditions of Business for TÜV Rheinland Companies in the Greater China Region, Testing and Certification Regulations of TRHK and as far as applicable the General and Common Terms and Conditions of Usage For all variants of the TÜV Rheinland test mark and in the case of verification services the TÜV Rheinland Verification Label General Terms and Conditions of Usage

As binding for both parties in all mutual business transactions. This recognition also applies to any future amendments to the above-mentioned document in particular due to new technical developments, changes in legislation, legal situations, court rulings, decisions by competent authorities, accreditation bodies and/ or accreditation requirements as well as market conditions unless the Client terminates this Agreement within one month of receipt of a notification of amendment.

The Client confirms with his signature that he has received the above-mentioned documents.

This recognition also applies to any future amendments to the above-mentioned documents unless the client terminates this Agreement within one month of receipt of a notification of amendment.

3. If the Client concludes a contract with another TÜV Rheinland entity, within the scope of which testing and/or QM system audits and/or certifications, verifications and/ or validations, within the meaning of clause 1 of the above-mentioned Testing and Certification Regulations, are to be provided by TRHK, the following order of validity shall apply in this respect in the event of conflicting regulations in terms of content:
 - a. Testing and Certification Regulations of TRHK
 - b. General Terms and Conditions of the respective TÜV Rheinland entity
 - c. General and Common Terms and Conditions of Usage For all variants of the TÜV Rheinland test mark
 - d. TÜV Rheinland Verification Label General Terms and Conditions of Usage
4. This Agreement shall be in effect for an initial term ending on December 31st of the current calendar year. It shall be automatically extended by another year unless terminated in writing by one of the parties hereto on or before November 15th of the respective calendar year.
5. This Agreement shall be governed exclusively by Hong Kong substantive law to the exclusion of private international law and the United Nations Convention on Contracts for the International Sale of Goods of 11 April 1980 (UN Sales Convention). Place of jurisdiction for all disputes arising out or in connection with this Agreement shall be Hong Kong.
