In order to protect the consumers in Morocco from substandard products and to assure safe and quality approved products enter the Moroccan market, the Moroccan Ministry of Industry, Trade, Green and Digital Economy (MICEVN) has implemented a Verification of Conformity (VOC) program starting 1st of February 2020 in line with law 09-24 and the decree No. 212-02 and decree No. 13-3873.

The VOC program requires that consignments falling under the list of regulated products are accompanied by a Certificate of Conformity to prove compliance to the national quality & safety regulations.

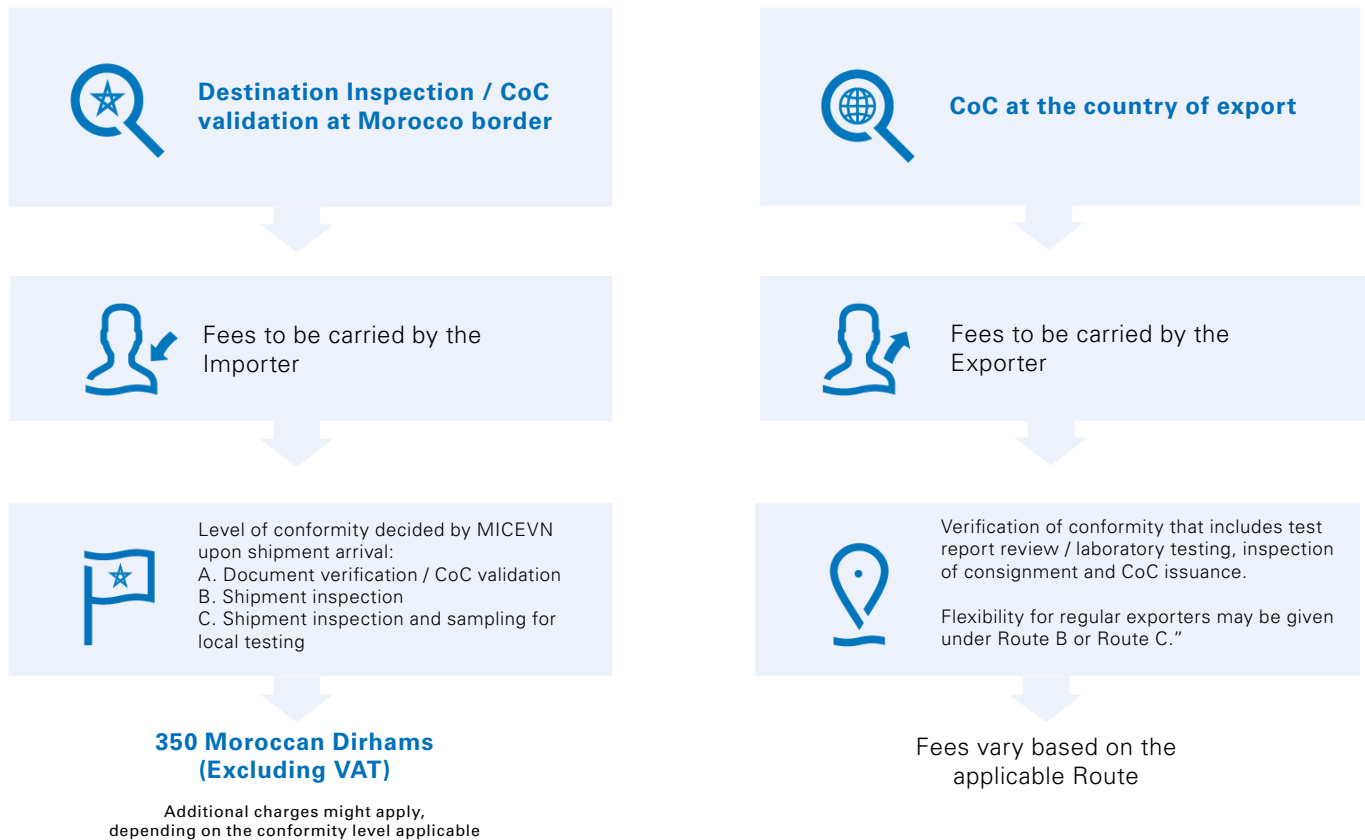

POSSIBLE CERTIFICATION ROUTES WHEN APPLYING FOR A COC AT THE COUNTRY OF EXPORT

Route	Customer Type	Details to Route
A	This route applies to traders or manufacturers that do not have frequent shipments or to those that have frequently changing product portfolios exported to Morocco	Verification of conformity documents (e.g. test reports, safety datasheets) and consignment inspection
B	Trader or manufacturers that have frequent shipments	Registration with an option of fewer consignment inspections
C	Manufacturers that have frequent shipments to Morocco	Licensing with an option of fewer consignment inspections considering an existing Quality Management System

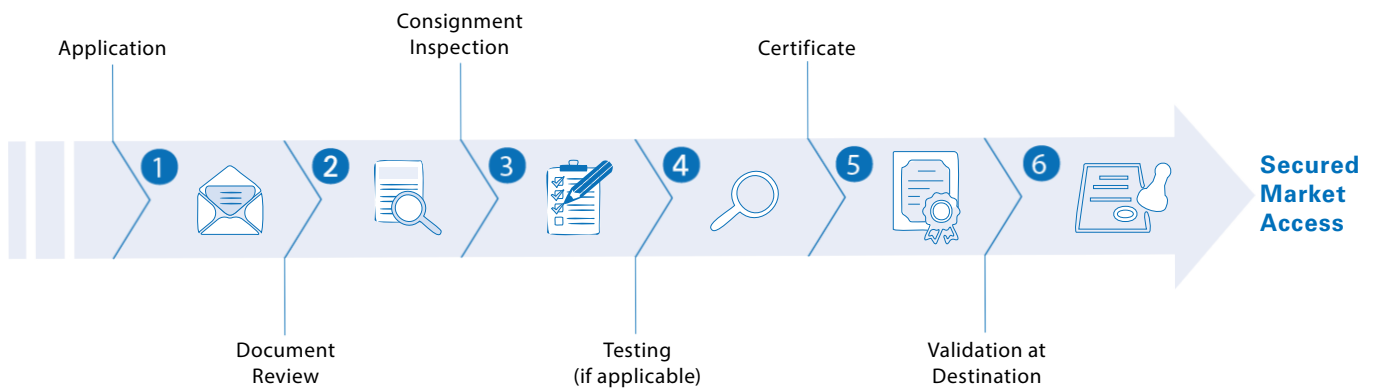
NATIONAL DEVIATIONS & MARKINGS OF MOROCCO VOC PROGRAM:

1. Accepted plug type: C and E
2. Voltage 220V or a range covering 220V and Frequency 50Hz
3. Labels / marking on products and immediate packaging have to be in Arabic
4. Marking CMIM is mandatory "For selected Toys, Electronics and Electrical Products"

In order to start the CoC process at the country of export, the following documents should be submitted:

- Complete and signed TÜV Rheinland application form
- Conformity documentation and/or test reports
- Invoice
- Packing List

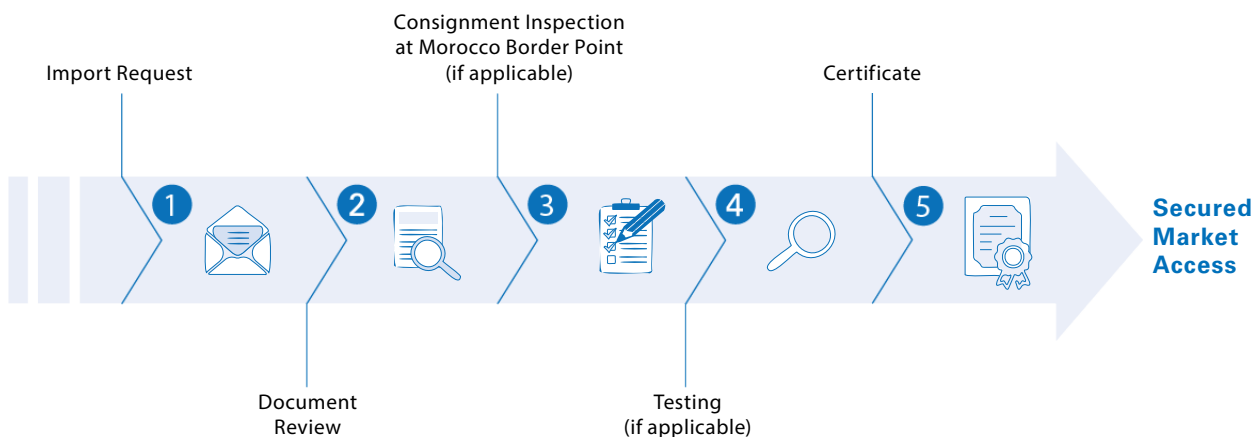
PROCESS FLOW: COC AT COUNTRY OF EXPORT
