with the EMC directive. As international testing service provider and Notified Body of the Federal Network Agency, we are authorized to perform EMC tests to ensure compliance with European and international standards – both in our test laboratories, which are equipped with state-of-the-art technology, and also on-site with portable equipment.

CHEMICAL AND ELECTRICAL SAFETY

Based on chemical analysis, we verify whether the materials of which your product is made comply with the statutory limits according to the German
